WorldDendro is an international scientific meeting held every four years for those interested in dendrochronology and related topics. It is an opportunity to showcase the community in which the meeting is held, the dendrochronology community broadly, and the important scientific contributions you all are making. This meeting is sponsored by the Tree-Ring Society (TRS) and designed to bring together researchers from all career stages. The past four WorldDendro Meetings have been held in: Thimphu, Bhutan (2018), Melbourne, Australia (2014), Rovaniemi, Finland (2010), and Beijing, China (2006).

Because of the global pandemic, AmeriDendro was shifted forward in time by two years to allow for an in-person meeting,

and we now resume our schedule with WorldDendro. The TRS encourages you to **engage with** your colleagues and consider proposing an exciting location for the next WorldDendro for 2024!

The TRS is working with other dendrochronology associations and societies to develop a formal bid package that will be forthcoming in the New Year. Did You Know that a new candidate for Oldest Tree in the World is Growing in Chile?

There is evidence that an alerce tree (*Fitzroya cupressoides*) discovered in the coastal mountains of Chile might be over **5400 years old** and therefore the oldest known tree on the planet. Dr. Jonathan Barichivich (Laboratory for Climate and Environment Sciences and Environment, Paris) has used a combination of dendro-dating of the outer rings of the massive tree together with modeling of the number of rings present in the rotten interior of the tree to come up with this estimate. A formal scientific article on this discovery is in development.
